Final Verification of Biometric Impression and original certificates/Testimonials etc. for the provisionally selected candidates for the post of Officer JMG – I/MMG II /III and Office Assistant(M) under general/SC/ST/OBC Category – CWE V for RRBs

In connection with the provisional allotment of candidates by IBPS under Common Written Examination for RRBs (CWE – V) it has been decided that the verification of Biometric impressions and original documents of the allotted candidates will be held **tentatively on 06.04.2017 and 07.04.2017 at 10AM/ 2PM at PBGB, Head Office situated at Natabar Paul Road, Chatterjee para More, Tikiapara, Howrah 711101. The actual date of verification will be intimated to candidates through their mail ID and via post at given address shortly . The list of provisionally allotted candidates along with their actual scheduled date and time of reporting for prerecruitment formalities will be made available on Bank's Website.**

To consider our offer of an appointment in our Bank, all the allotted candidates are, hereby, advised to produce the following papers/ certificates relating to the particulars furnished by them in their application on the date of verification.

1. Print out of the original application to IBPS and copy of valid Common Written Examination (CWE-V- RRB-2016) score card issued by IBPS.
2. Madhyamik/10th standard admit card/Birth certificate as proof of age acceptable to the Bank.
3. All the educational certificates and mark sheets starting from 10th standard and computer Literacy certificates, if any.
4. Schedule cast/ Schedule Tribe certificates or OBC Certificate along with non- creamy layer certificate from the appropriate authority not older than one year, if applicable.
5. Experience certificate and no objection certificate from the present employer, if any.
6. Testimonials in support of character i.e. two character certificates from the referees not related to the candidate. Generally Head Master of School, Principal /Head of the Deptt. of College/University, Regd. Medical Practitioners, Commissioners/ councilors/Gazetted officers/Bank Officers./MLAs/MPs/Judges/Advocates etc. are acceptable referees. The Certificates must bear the Full name, address, Telephone No. of the Referees.
7. Photo Identity and address proof are to be submitted for identification of the candidates with their name and permanent address to the satisfaction of the bank. For this purpose the candidate may produce any of the following documents in original with photocopy providing full information about your name and permanent address:

(a) Voters Identity Card, (b) Aadhar Card, (c) Driving license, (d) Pass port, if any.

8. Passport size photograph (2 copies). Photograph should be the same as was used at the time of online Examination.
9. Medical Certificate of physical and mental fitness of the candidate issued by a Medical Officer not below the rank of Chief Medical Officer of Health (CMOH)/ Superintendent of Govt. Hospital.
10. PAN Card and AADHAR Card are must to be submitted at the time of verification.
11. Originals in support of any other particulars, if furnished in your application.

Please note that the Biometric impressions will also be verified through TCS on the date of verification. Request for change of date will not be accepted in any circumstances. Further, if any candidate fails to submit any certificate/document/NOC on reporting date, he/she will not be considered for appointment.

Tentative date of joining shall be 24.4.2017 to 26.04.2017.

All the procedure i.e. verification of original documents, Biometric Impression matching are mandatory and if any candidate fail to turn up on the date of verification , it will be presumed that he/she is not interested for appointment in this Bank and no further correspondence shall be made in this regard
